- We constantly monitor our environmental performance and achieve continuous improvement.


All persons working for our corporation are obliged to follow these standards and to actively participate.

Environmental Targets for 2018

- For 2018, the values per employee for consumption of electrical energy, gas, water and fuel should be below the values of 2017. Metrics, where no benchmark for 2017 is available (paper consumption, waste, recycle rate) will also be monitored and corrective actions initiated in case of negative trends. Based on the data of 2018, quantitative targets for 2019 will be defined.
- By the end of 2018, only suppliers with an environmental management system should be in the strategic supplier list. Exceptions must be justified and documented.
- By the end of Q3 at least 75% of the staff in scope should have conducted the annual environmental awareness training. By the end of 2018 the figure should be above 90% and stay there.
